7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2077/01/29 (11-May, 2020) at the Bhagwatimai Rural Municipality, Dailekh.

Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 14,60,000.00 which shall be valid for 30 days beyond the validity period of the bid.
